

TOWN COUNCIL PROCEEDINGS - UNAPPROVED

SEPTEMBER 17, 2018

JACKSON, WYOMING

The Jackson Town Council met in regular workshop session in the Council Chambers of the Town Hall at 150 East Pearl at 3:10 P.M. Upon roll call the following were found to be present:

MAYOR: Pete Muldoon.

COUNCIL: Jim Stanford, Hailey Morton Levinson, Don Frank and Bob Lenz.

STAFF: Larry Pardee, Roxanne Robinson, Audrey Cohen-Davis, Lea Colasuonno, Todd Smith, Steve Ashworth, Floren Poliseo, Tyler Sinclair, and Sandy Birdyshaw.

Residential Rental Ombudsman Program. Audrey Cohen-Davis and Todd Smith made staff comment on this proposed program.

A motion was made by Jim Stanford and seconded by Hailey Morton Levinson to direct staff to continue refining the general framework and policies and procedures for the ombudsman position within the Victim Services Department of the Jackson Police Department and bring back a draft ordinance to Council at a future date for approval. Mayor Muldoon called for the vote. The vote showed all in favor and the motion carried.

Parks and Recreation Strategic Plan. Steve Ashworth made staff comment on the draft Strategic Plan released in April 2018. The executive summary was discussed for this ten-year plan. The plan does not lock Council into any specific decision or priority, rather provides a road map for development and programming. Public comment was given by David Ellerstein of the Parks & Rec Advisory Board. No action was taken by the Town Council.

Sign Code. Lea Colasuonno made staff comment on proposed changes to the Town's sign code needed due to a recent Supreme Court constitutional law ruling. Discussion included that the sign code should be re-worked so it does not regulate signs based on the content or subject matter of the sign, but rather, based on content-neutral features; separate rules should be removed for categories of signs that are defined by the content or subject matter of their message, review "exceptions" to regulations to make sure they are not content based, and to ensure that the sign code regulates with content neutral, "time, place, and manner" regulations. Tyler Sinclair made staff comment on sign enforcement.

A motion was made by Hailey Morton Levinson and seconded by Don Frank to direct staff to draft and present a repeal ordinance for the necessary portions of the sign code for a future Town Council meeting and to revise the sign code LDRs as necessary under federal law and present such at a future Town Council meeting. Mayor Muldoon called for the vote. The vote showed 4-1 in favor with Stanford opposed. The motion carried.

Adjourn. A motion was made by Hailey Morton Levinson and seconded Don Frank to adjourn. The vote showed all in favor and the motion carried. The meeting adjourned at 4:49 P.M.
