SUBJECT: TEMPORARY SIGN PERMIT – Laff Staff Improv Shows

STATEMENT/PURPOSE

To approve or deny relief from the Town's sign ordinance for the use of temporary signage not requiring a special event or exposition license.

BACKGROUND/ALTERNATIVES

The applicant has requested a temporary banner to be located at 105 Buffalo Way, Albertsons during:

October 7, 2018 – October 14, 2018 December 2, 2018 – December 9, 2018 February 3, 2018 – February 10, 2018 March 10, 2018 – March 17, 2018 April 28, 2018 – May 5, 2018

Section 4670.I of the Town's Land Development Regulations allows Council to approve up to four (4) offsite banners. The event does not require any Town services; therefore, a special event license is not required. Staff recommends approval, as the Town has permitted such signs in the past, as long as all other regulations for signage are complied with.
