

**EXCEPTION ORDER #1**

**TO SNOW KING MOUNTAIN RESORT TO PERMIT PERSONAL UPHILL  
RECREATION AT SNOW KING MOUNTAIN RESORT**

**EXCEPTION TO  
TETON DISTRICT HEALTH OFFICER PUBLIC HEALTH ORDER #20-2**

**ORDER CLOSING CERTAIN PUBLIC PLACES; and PLACING  
RESTRICTIONS ON RESTAURANTS WITHIN TETON COUNTY, WYOMING,  
INCLUDING THE CITY OF JACKSON, WYOMING**

WHEREAS, Travis Riddell, M.D. serves as the Teton District Health Officer pursuant to W.S. §35-1-306(a); and

WHEREAS, the State Health Officer, Alexia Harrist, M.D., PhD, gave authorization on March 17, 2020, pursuant to W.S. §§35-1-227 and 35-1-240(a)(i) and (iv) to Dr. Riddell, the Teton District Health Officer, to issue Public Health Order #20-2 *Order Closing Certain Places; and Placing Restrictions on Restaurants within Teton County, Wyoming, Including the City of Jackson, Wyoming*; and

WHEREAS, Dr. Riddell, the Teton District Health Officer, issued Public Health Order #20-2 on March 17, 2020; and

WHEREAS, Public Health Order #20-2 allows for the District Health Officer to grant exceptions on a case by case basis after evaluating the request; and

WHEREAS, Public Health Order #20-2 closed "All ski resorts including Snow King, Grand Targhee, and Jackson Hole Mountain Resort"; and

WHEREAS, Snow King Mountain Resort has requested an exception to Public Health Order #20-2 to allow personal uphill recreation to occur at the Snow King Mountain Resort as well as grooming to occur; and

WHEREAS, Dr. Riddell, the Teton District Health Officer, has reviewed the exception request and finds that the request should be granted because the activity does not pose an increased public health risk and may benefit the community in having an outdoor activity to participate in.

NOW THEREFORE IT IS HEREBY ORDERED, that an exception to Public Health Order #2 is hereby granted to Snow King Mountain Resort to allow personal uphill recreation at Snow King Mountain Resort with the following restrictions:

1. Skiers, snowboarders, snowshoe users, bicycles, walkers, and runners may travel uphill on Snow King Ski Hill located at the Snow King Mountain Resort under human power and then ski, snowboard, snowshoe, bicycle, walk, or run back down the mountain.
2. Grooming is allowed to be done by Snow King Mountain Resort.
3. Resort Services shall remain closed.
4. All lifts shall remain closed.
5. No congregating at the base, top, or anywhere on the mountain of more than 10 people.
