

Karns Meadow Park  
Zoning Map Amendment Narrative  
Tracts 1, 2, 3, 4, 5, & 6

Karns Meadow is located on Karns Meadow Dr. in the Town of Jackson, Wyoming. This 41.6 acre undeveloped park consists of 6 Tracts and is bordered by roads on all sides with sidewalks on the southern, and a portion of the eastern sides. The Flat Creek runs diagonally through the site, from the northeast to the southwest. All of Karns Meadow is within the Natural Resources Overlay and provides habitat for many species and ecosystem services for the Jackson community.

Presently, all Karns Meadow Park Tracts are zoned Neighborhood Low Density (NL-1), which is inconsistent with the present and desired future use of the park. We are asking for consideration of a rezone of Karns Meadow Park Tracts 1, 2, 3, and 6 to the Park and Open Space (P) zone. Tract 4 would also be rezoned to the Park and Open Space (P) zone, with the exception of approximately 24,000 ft<sup>2</sup> on the eastern side of the park, which is reserved for housing and would be rezoned to NL-3, which is the most consistent zone for the conservation easement allowed use (See Attached Map). Tract 5 would be rezoned to Public/Semi-Public. A rezone to P and P/SP for these Tracts will also be consistent with the allowable uses found in the conservation easements (See Attached Map).

A neighborhood meeting was held on March 9th and 10th, 2023, to familiarize the community with the proposed ZMA and also the allowed uses directed by Town Counsel. Public opinion on the project was collected through a Public Input survey, March 9-31 (see attached).

#### Findings for Approval

1. Is consistent with the purposes and organization of the LDRs;
  - Complies- The Town of Jackson Land Development Regulations Div. 1.3 Purpose and Intent states that focus is on the Community Vision and Implementation of the Common Values of Community Character. The proposed rezone of Karns Meadow Park Tracts 1, 2, 3, 4, 5, and 6 will align with these as it is a step toward the Park contributing to the Community Vision and Character.
2. Improves implementation of the desired future character defined in the Illustration of Our Vision chapter of the Comprehensive Plan;
  - Complies- A rezone to P will align with the Comprehensive Plan Illustration of Our Vision as it states that wildlife use and recreational opportunities will need to be carefully balanced in Karns Meadow, moving forward. Rezoning these Tracts will allow for this balance.
3. Is necessary to address changing conditions or a public necessity; and
  - Complies- Complete Neighborhoods require Quality Open Space. The Midtown Subarea is dependent on Karns Meadow Park to fill this role and the rezone to P or P/SP (Tract 5) is the first step in allowing it to function as a Quality Open Space.
4. Is consistent with the other adopted Town Ordinances.
  - Complies.

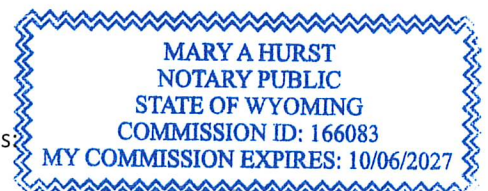

Love the existing layout! This is well designed to both protect core habitat used by wildlife and birds, and allow for running/walking/biking around the exterior the meadow. I live in town and if this gets built I would regularly use this as an addition to my running loop. I disagree that the paths will impact deer any more than the existing highway. Deer may change their time of day usage, but will still access the meadow after dark, and individuals that are more tolerant of humans (e.g. the deer that winter in town) will likely hardly change behavior due to addition of trails on the Park's perimeter. Would love to see more invasive species control here. Also - park has been used (especially the area behind the gas station) as a refuge for homeless during summer. Surprised this is not more a part of the conversation. This should probably be taken into account and local shelter space ensured. Gotta have courage to fight the NIMBYs though! Once/if sufficient shelter space is available, camping/dog leash/dog poop restrictions should all be enforced if possible. And insane amount of dog poop from the 15% of people who don't pick up poop is already washing into the creek here and at other locations along the creek.

A good compromise with "environmentalists" would be to not have XC skiing (focus grooming on existing pathways) and to enforce dog leash laws with citations especially in winter.

The mule deer that frequent Karns meadow cross a five lane highway, two bike paths, two sidewalks, an office center, raft company, gas stations, and so on. A walk and bike path is of no consequence to them. That said, my strongest suggestion is to make a path from the end of Kelly Avenue connect to virginian lane by bisecting the virginian hotel property. This would be a huge improvement to the hotel guests as it would give them easy access nature access and it would give the residents a way to cross town, either on foot or bike, without having to deal with the high traffic intersections on Flat Creek ave, Snow King ave, and Virginian Lane. This would be a huge benefit in the Winter time when the bollards are gone and snow king ave gets downright hostile to bicyclists. I do no see a strong need for the second bridge and the other pathways (yellow and red) but I have no opposition to them. The blue pathway, while perfectly fine where it is would be far cheaper, easier to construct, and less likely to stir the ire of antirecreation organizations, if it was constructed more directly to the end of Kelly Ave.

My hope would be for keeping the Karns Meadow a year long walking and biking route through town, and hopefully someday a pathway would go from the high school to dairy queen so we can promote nature based transportation that this beautiful place deserves Adding improved infrastructure for winter cycling gives the residents another important option for transportation as the Start bus is limited, walking is slow, and cars should be a last resort instead of a first. Fat ebikes with appropriate studded tires are an amazingly effective tool for navigating the town of Jackson and their usage should be subsidized and encouraged whenever possible. For the most part, the Town should pride itself on taking steps in this direction by plowing the Russ Garaman trail in the winter time.

This opporunity for quiet enjoyment in natural habitat is not found elsewhere in the heart of Jackson. Don't allow dogs, wheels of any kind except wheel chairs...No restroom needed if no picnic shelter. These added facilities are unnecessary, expensive, and require ongoing maintenace. Other urbanized areas now appreciate the value to the public of such low key "nature sanctuaries." Altready there are plenty of other recreational options (including pathways!), and access to nearby local town parks with picnic shelters as well as extensive trail systems on national forest lands. 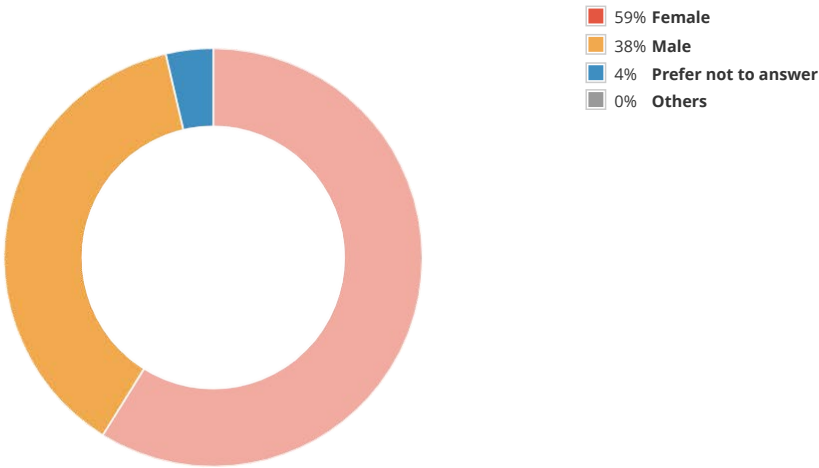

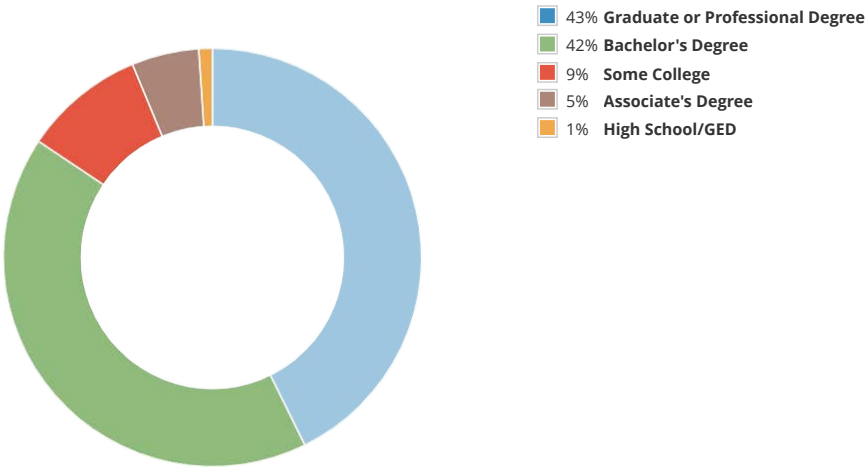

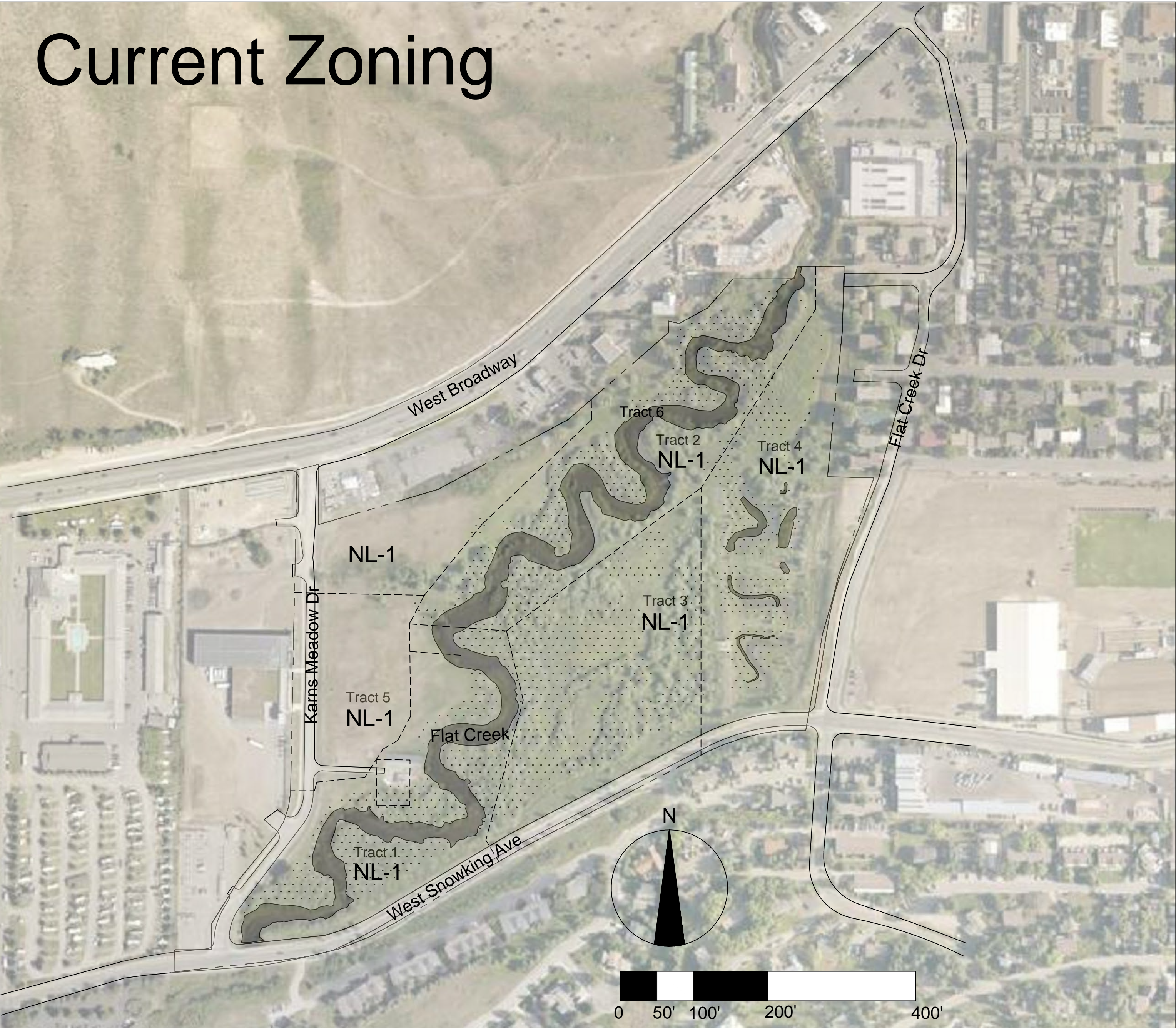

The area to be zoned NL-3 should be at least 22,500 sf in order to obtain 3 future lots.
