This application is required for any person seeking a license to engage in Door-to-Door Commercial Solicitation at private residences or Commercial Solicitation on streets, highways, or sidewalks located in the Town of Jackson. The application must be approved, and a license must be issued by the Town before it is legal to engage in Door-to-Door Commercial Solicitation or Commercial Solicitation within the Town. The application must be fully completed by the applicant to be processed.

A license is not required for merchants conducting a sale otherwise permitted in the Town's Municipal Code or for persons engaged in Noncommercial Solicitation.

Expiration and Renewal: Commercial Solicitation Licenses expire each year on December 31 and must be annually renewed by submitting this application prior to December 31.

Annual License Fees: The annual license fee must be submitted with the application. This fee is non-refundable and shall not be pro-rated based on the time of year the application is submitted. Submission of the fee does not constitute approval of an application. If the application is denied, a refund of the fee will be issued minus a \$50.00 application fee. A late fee will be assessed for untimely renewal applications.

Change of Location: If a Commercial Solicitation License holder seeks to change the location(s) of their solicitation, a new application is required for the approval of the location(s). An application based on a change of location does not require resubmission of the annual license fee, but does require a \$50.00 application fee.
